LEADERSHIP IN AA:

(Excerpts from Bill W.'s article in the April 1959 Grapevine. See Concept IX, page 38 of "Twelve Concepts for World Service" in the service manual for the full article)

Somewhere in our literature there is a statement to this effect: "Our leaders do not drive by mandate: they lead by example." In effect, we are saying to them, "Act for us, but don't boss us."...

Therefore, a leader in AA service is a person who can personally put principles, plans, and policies into such dedicated and effective action that the rest of us want to back him up and help him with his job. When a leader power-drives us badly, we rebel; but when he too meekly becomes an order-taker and he exercises no judgment of his own—well, he really isn't a leader at all...

Good leadership originates plans, policies, and ideas for the improvement of our Fellowship and its service. But in new and important matters, it will nevertheless consult widely before making decisions and actions. Good leadership will also remember that a fine plan or idea can come from anybody, anywhere. Consequently, good leadership will often discard its own cherished plans for others that are better, and it will give credit to the source...

Good leadership never passes the buck. Once assured that it has, or can obtain, sufficient general backing, it freely takes decisions and put them into action forthwith, provided, of course, that such action be within framework of its defined authority and responsibility...

Another qualification for leadership is give-and-take, the ability to compromise cheerfully whenever a proper compromise can cause a situation to progress in what appears to be the right direction. Compromise comes hard to us all-or-nothing drunks. Nevertheless, we must never lose sight of the fact that progress is nearly always characterized by a series of improving compromises. We cannot, however, compromise always. Now and then, it is truly necessary to stick flat-footed to one's conviction about an issue until it is settled. These areas situations for keen timing and careful discrimination as to which course to take....

Leadership is often called upon to face heavy and sometimes long-continued criticism. This is an acid test. There are always the constructive critics, our friends indeed. We ought never fail to give them a careful hearing. We should be willing to let them modify our opinions or change them completely. Often, too, we shall have to disagree and then stand fast without losing their friendship.

WE ARE NOT ALONE

On Saturday, 21 October, a Vancouver Intergroup (IG) representative attended a seminar meeting at the Tacoma AA Central Office (C.O). Invitations to this gathering were sent by the Pierce County C.O. Office Manager to all Intergroup/Central Office addresses in our Western Washington geographic region - and there are about 10 such locations from Vancouver Canada to Portland OR. Pierce County C.O. and the Greater Seattle IG sent representatives to the annual Intergroup/Central Offices of AA (ICOAA) Conference held with AAWS and AAGV in Virginia earlier in the month. These ICOAA Conference participants shared their experience with the group who traveled to Tacoma.

A digest of the Tacoma meeting minutes is offered below:


The ICOAA Conference included many breakout workshops. One such workshop discussed the differences between AA Intergroup structures and Central Office structures. Part of the discussion included the bylaws created by other intergroups/c.o.'s and how some offices offer copies of their bylaws to aid other offices. Another workshop on Online Services illustrated various design standards that are elemental to a good website along with website management best practices.

The Seattle IG described a workshop about product inventory control and spoke of semi-annual product inventories.

One workshop at ICOAA was on how to increase participation at the IG/CO level of general service to AA. The Boston IG reported 66% of revenue from home groups. It seems that 33% group participation seems to be a common level among all IG/CO's.

An observation at the ICOAA; it's becoming more common for the places where AA meeting are held (churches, etc) to require liability insurance. Groups can ask the church board if they can be added to the church's policy (and agree to pay the added premium). Sacramento intergroup buys liability through an insurance broker for non-profit organizations. Seattle IG has been working with a broker and discovered that groups can be added as a rider to such a policy at no charge. This insurance service could be a source of value to home groups.

Altogether, this small group of 8 IG/CO volunteers and staff had a very productive 4 hours together in Tacoma. There were some handout documents, including the reading recommended for all who are interested in this area of AA Service - the recent AAWS 'Box 459' article from Fall 2017 issue

The Steering Committee minutes September 11, 2017 were reviewed. Motion to approve; seconded; approved.

The Intergroup Rep meeting minutes for September 18, 2017 were reviewed.

HOTLINE REPORT: Hotline Chair is looking for an AA volunteer to fill the Hotline slot for Fridays from 9:00 pm to Saturday mornings at 6:00 am. Volunteers may sign up on line on our website or call our Intergroup Office.

TREASURER'S REPORT: Treasurer's Report was reviewed. The format of the Treasurer's Report was discussed so we are not showing a debit of our Gratitude Dinner expenses in our Report. Laurie H. shared various QuickBooks procedures. An additional category entry was discussed.

INTERGROUP REPORT:

The Intergroup Rep meeting minutes for September 18, 2017 were read and approved with corrections as mentioned during meeting.

The Steering Committee minutes for October 9, 2017 were not read as corrections are still being made therefore we do not currently have a final draft.

HOTLINE REPORT: Looking for a volunteer to take the Friday from 9:00 pm – Saturday morning 6:00 am shift. Laurie states that she heard men were sent to a woman's 12 step call.

TREASURER'S REPORT: Robert asks if the new account category was created. Yes, next month's report with reflect those changes. Phil motions to approve treasurer's report, Robert seconds. Approved.

INTERGROUP REPORT: Calls for September totaled 97; 42 general/office inquiries, 50 meeting calls and 5 were 12 step calls. Marcy mentions that the vacuum in the office has broken and asks if anyone might have an extra one to donate. Tom states he might.

WEBSITE REPORT: Total of 1,282 visitors to the website in September; 818 were new visitors and 464 were returning visitors. Scott, our web servant, has fixed an issue with the calendar updating correctly. He is still working on the online order form.

COMMITTEES:

Finance Committee:

Treasurer's Workshop: Workshop was held on September 23rd. Greg reported we had five attendees along with the Western Washington Area 72 Alternate Treasurer.

Jamboree Table: Greg noted we made approximately \$95 this year and that there seemed to be less people in general from the previous year.

2018 Budget/Forecast: Greg noted that we are moving away from a traditional budget model and moving into a forecast type model for the upcoming year. In the 2017 budget expenses were evenly distributed over the 12 months, while in fact we know when certain items are due throughout the year such as insurance and domain names for the website. Therefore, a forecast will more accurately show the financial position of the office. Greg also points out a few new items going into the 2018 financial forecast such as staff development and financial projects.

Greg requests IG to circulate this Forecast document among your groups and return for discussion and a vote at the Nov IG meeting.

Electronic Banking: Greg shared a completed pamphlet he feels might be beneficial in generating a new revenue stream for the office through accepting personal contributions to the Intergroup. In this he recommends Intergroup opening an additional checking account designated solely for the purpose of direct deposits from individuals.

Gratitude Dinner: John, the cook, and Deb went shopping for paper products and other necessities for the dinner but are waiting to purchase the meat closer to the date. Deb reports that she had about 8 people show up and willing to volunteer for one of the planning meetings. She has attended several other meetings recruiting and marketing for the event. All together Deb notes she has about 40 different people willing to volunteer for the evening of the dinner. Marcy and Deb will begin calling the volunteers in the upcoming weeks to confirm their availability. Deb will be assigning duties accordingly. She also shares that the centerpieces have been put together by herself and a few volunteers.

OLD BUSINESS:

<u>Hurricane Relief</u>: Included in the handout is some information from GSO that Virginia provided to the Steering Committee regarding disaster relief stating that you are not able to earmark money sent into GSO for a specific purpose. Jeff H., the chair of Wayfarer's, informs us that Wayfarer's took voluntary donations from those attending the speaker meeting and sent directly to the Houston Central Office.

<u>CPA</u>: Becky will be reaching out to BLH Accounting to advise the Steering Committee on non-profit guidelines and to verify whether we are in conformity.

NEW BUSINESS:

Electronic Banking: Greg asked the group to approve a new bank account to receive funds from the Individual Contribution Subscription program. Greg noted that an additional account will not cost anything. There was discussion whether we already had enough accounts and whether or not one could be repurposed. It was also suggested we get input from BLH Accounting. Beci will be speaking with BLH to seek their input. Since the Contribution program is just starting and the need is not immediate, it was decided to table the discussion pending further input.

<u>Elections</u>: There will be several positions on the Steering Committee coming available including Position #2, Position #3, Alternate and Recoding Secretary. Nominations will take place at the November and December Intergroup Meetings. The elections will be at the December 18th, 2017 Intergroup Rep meeting at 6:30 pm with terms beginning January 2018.

"In AA we talk a great deal about each other. Provided our motives are thoroughly good, this is not in the least wrong. But damaging gossip is quite something else. Of course, this kind of scuttlebutt can be well grounded in fact. But no such abuse of the facts could ever be twisted into anything resembling integrity. It can't be maintained that this sort of superficial honesty is good for anyone. So the need to examine ourselves is very much with us. Following a gossip binge we can well ask ourselves these questions: 'Why did we say what we did? Were we only trying to be helpful and informative? Or were we not trying to feel superior by confessing the other fellow's sins? Or, because of fear and dislike, were we not really aiming to damage him?' This would be an honest attempt to examine ourselves, rather than the other fellow. Here we see the difference between the use of the truth and its misuse. Right here we begin to regain the integrity we had lost."
