Intergroup/ Central Office: Then and Now

Established and supported by local groups to carry out the functions of a centralized office, intergroups have provided thousands of desperate alcoholics with their first contact with Alcoholics Anonymous, either over the phone, in person, or, increasingly, online. With 469 intergroups/central offices listed with G.S.O. in the U.S./ Canada alone (and nearly 700 worldwide), A.A. is so easily “searchable” these days that we often forget that, at one time, it played a little hard to get. Back in the early days, “A.A. wasn’t that easy to find,” wrote one old-timer. “A carefully selected group of priests, judges and policemen knew about A.A.; our phone number wasn’t listed, and it could be gotten only by dialing Information.” This was a deliberate attempt to ensure that anyone wanting to get sober was sincere enough to make a real effort. But gauging the level of someone else’s desire to quit drinking was an often subjective judgment that the Third Tradition fortunately did away with.

More than fifteen hundred times a year a voice on the telephone cheerfully offers understanding and compassion to the alcoholic who has sunk into the throes of despair and hopelessness. Volunteers have saved many a life just by proving that in Alcoholics Anonymous we really care. The Internet has proved a game changer for Intergroup/Central Offices. Matthew C., office manager of the Ventura County Central Office (VCCO), feels that there is a “certain comfort” about being able to explore the answers to questions individuals may have about their drinking without having to speak to someone, but there is also something that may be lost: “that one-on-one connection with another person. So, the websites do encourage people to call, 24/7.” When they do call, miracles can occur.

Many of those who have never had occasion to call intergroup (or who look up meetings on websites in strange towns without quite thinking of who is maintaining that website) wonder why they should support intergroup/central office with their financial donations. While cooperating closely with G.S.O. and local general service district and area committees, it is not unusual for intergroup/central offices to seem apart from the general service structure. However, as noted in The A.A. Service Manual (page S42), “Many areas find that a liaison between the intergroup/central office and the area committee is very helpful in maintaining good relations and communication. In some areas the liaison has a vote at the assembly; in others, a voice but no vote.” And further, the General Service Office publishes Guidelines and other service material that share the accumulated experience of intergroups and central offices in the United States/ Canada and worldwide. These define an intergroup as “an A.A. service office that involves partnership among groups in a community — just as A.A. groups themselves are partnerships of individuals. It is established to carry out functions which are best handled by a centralized office.... It exists to aid the groups in their common purpose of carrying the Alcoholics Anonymous message to the alcoholic who still suffers.

According to Coco T., executive secretary of the New York Intergroup (NYIG), the NYIG office pays \$10,000 a month in rent alone — a relatively modest fee, considering Manhattan real estate prices, but not a stroll in the park either. When asked what the future might hold for intergroups, she replies, “We answer to the Fellowship; we are responsible to the groups. Ultimately, our future depends on them. I owe my life to Alcoholics Anonymous, and I would hope intergroup is always there. Young people coming into A.A. need to be educated about intergroup, and need to learn to volunteer. An A.A. without intergroup would not be A.A., really. “If we are not here, if someone calls for help and there is no one to pick up the phone, then A.A. has failed them.” Coco T., executive secretary of New

As Matthew C. at VCCO sees it, the idea of intergroup is the idea of A.A. itself: “A suffering alcoholic talks to someone who is feeling the way they are feeling, who understands and has been through the humiliation they have experienced, who helps them know that they are not alone after all.”

Currently, Intergroup Finance Committee (formed to monitor financial performance), is drafting a 2018 Intergroup Budget. Please feel free to add your voice as we make financial recommendations to the Intergroup Steering Committee. We want to create new ways of financially supporting the Intergroup in addition to current sales and contributions (not to mention the prodigious efforts of volunteers and general Group support to the Fellowship of AA). Look for future discussions in our Primary Purpose Newsletter regarding a convenient method for individual direct financial donations to the Intergroup.

A member, who is also a Treasurer, writes of gaining at least 4 pertinent ideas from attending this Workshop:

1. Create a Policy Record for the Treasurer and Archivist to record past policies we have voted on for future reference.
2. Create simple accounting forms for all group treasurers to use or modify.
3. Create an audit team.
4. Put together a FILE FOLDER to pass on to the next Treasurer.

It was established that a quorum was present to conduct our Steering Committee business meeting as set forth in our Guidelines.

The Steering Committee minutes for August 14th, 2017 were reviewed. Motion by Robert to approve; seconded by John. Approved.

The Intergroup Rep meeting minutes for August 21st, 2017 were reviewed.

HOTLINE REPORT: All slots are currently filled. Please continue to spread the word that you may sign up to volunteer on line or call our office.

TREASURER'S REPORT: Treasurer's Report was reviewed. Moved and seconded to approve. Passed.

INTERGROUP REPORT:

Telephone Calls: Of the 102 total calls to our office, 53 were general/office; 45 meeting requests, and four 12 step calls.

Meeting Schedule Format: We sold 385 of our original format schedules, and 65 of the new format arranged by area. We will continue to formulate the new schedule by area. During this time both formats will be available to purchase. Will review findings in February 2018.

WEBSITE REPORT: Of the 1,386 visits to our website, 439 were new visitors and 947 returning visitors.

OLD BUSINESS:

Intergroup Budget: 2018 budget assumptions were presented for approval, several suggestions were noted. Two projects were also presented; the first to help fund a member of the Steering Committee to attend an Area quarterly and possibly the Central Offices National Convention, and

COMMITTEES:

Finance Committee: Monthly budget monitoring information and graphs submitted. The Treasurer's Workshop is all set for September 23, 2017 with Area participation.

Gratitude Dinner: Deb T., the Gratitude dinner chair, informed us of upcoming committee meetings on 10/4/17 at the Intergroup office at 5:30 pm, and 10/7/17 at Camas Friends Church at 9am or 1:15pm.

NEW BUSINESS:

Jamboree Table (October 13th & 14th): Greg, Deb, Beci and Phil have made themselves available to work the Intergroup table during the Jamboree.

Hurricane relief: There was discussion as to how can we help those effected by the hurricanes. Robert will re-search for more information to be presented to the IG reps.

Prudent Reserve: Discussion regarding the current prudent reserve goal being at \$18,000. The standard reserve fund is regularly three months operating expenses. It's been found that our current prudent reserve goal is based on approximately \$6,000, being the monthly office expenses when in actuality our monthly operating expenses are less than \$4,000, thus three months expenses would be \$12,000 as the goal. The current reserve fund calculation includes monies to purchase literature, coins, etc., which is self-funding when items are sold. It was suggested to only utilize operating expenses as the basis for calculating the prudent reserve goal. Currently the prudent reserve has a balance of \$14,430.57. It will be presented to the IG reps if the reserve should be decreased.

2017 numbers for consideration of re-calculating our Prudent Reserve

Average Monthly Operating Expenses (less COGS) = \$3,800 (rounded up), which gives us a 3-month figure of \$11,400 (rounded up to \$12,000)

Social activities: Discussion on how, especially during the summer months, is it best to get the word out into the AA community of any and all upcoming events/social gatherings.
