Experience, Strength and Hope...

My life started to fall apart in 2009 at 32 years old. I had quit my high paying corporate job, moved in with my boyfriend in a new city and expected him to fix me. Instead he began to look elsewhere for a new girl-friend and I slipped quickly into every day drinking and extreme drinking on the weekends. It was a pivotal trip to Miami, Florida that woke me up. We had been drinking all day with a group of friends, I did what I usually did when I drank too much which was get angry, accuse him of cheating and then start to seek attention from other men. The boyfriend, sick of my behavior told me to leave. I remember stumbling down the crowd of people outside Miami's hottest night clubs and running into a sweet girl who found me a taxi. The taxi took me back to my hotel where I withdrew all the money from my bank account and gave it to the taxi driver. I made it to our hotel room and all I could think about was dying. I was a mess. A failure. I couldn't do anything right. I was too old to be in this situation. No one wanted to marry me, I'm going to jump out of this hotel room. I quickly went to the sliding door but I couldn't open it. I fought and fought with it, looking out at what I thought was going to bring me relief. I had to escape my brain, when is the pain of being alive going to be over? And then I remembered all those years ago when my dad made me promise never to attempt suicide again. So I did the only thing left to do, I called my dad.

That was such a dark night for me, one that I will never forget. I believe my higher power intervened on my behalf and that She has continued to along the way. Through the help of a counselor (whom I couldn't pay at first because I had given all my money to the taxi driver) and group therapy I began to see that alcohol was my problem. I was miserable, trapped in the viscous cycle that other people were the root of my problems. In Alcoholics Anonymous I was able to feel connected to other people for the first time in my life. I began to see that I could take responsibility for myself and my choices. I could have these things called boundaries with my mother and I could be mad at her while learning that I had a part in that. Just listening to others talk made my brain stop for a while. It was and is still such a relief.

Experience, Strength and Hope Continued...

In sobriety I met my husband and we had the sweetest backyard wedding, we bought a house and we had our son. I stopped going to meetings as much, I stopped working with my sponsor and soon all my problems came crashing down on me. Here I was three years sober with all the things I wanted and yet I was miserable, discontented and depressed. I was told I needed some emotional sobriety. "What the fis that?" I thought "this AA stuff really confuses me". My higher power wasn't messing around because as I looked through the meeting schedule for the new city I was living in, I found a women only meeting called Emotional Sobriety that met at lunch time and I could bring my son. I did some major growing up in that room. Those women listened to me, held me, guided me and made me laugh. I met the woman who would sponsor me with intense honesty and call me on my bullshit. She would challenge me in a way no one had ever challenged me. I grew so much from that time with her. We worked the steps thoroughly. I made amends to certain people I thought it impossible to do so. And then I stopped. I asked another lady to sponsor me, she had a teacher back ground and I felt like I needed some more teaching, I had so many questions that would seemly irritate my last sponsor. I worked the steps again!! When it came time to make amends, it would be different this time. This time I was willing. I was willing to go to any length. With the help of my higher power I faced the people I had hurt my first year of sobriety. I owned my side, I showed up. I had to pray and pray just to show up, I thought I was going to die. The reward from those experiences has been greater than I could have ever imagined. Today I get to share that I messed up and acted like a crazy person in sobriety, no drinking or drugging even happening. I get relief today knowing that I can go anywhere without fear of running into them and I can stop punishing myself for messing up. One of the craziest things I learned was that I have a condition that two other women in my family have that has made them unable to have children. For years, I suspected that I had it, but every doctor I went to would dismiss me and tell me it was in my head. Today I know that I do have it and yet I have been blessed with two beautiful children. That's all my higher powers doing not mine. Today I'm so grateful to be a part of a fellowship of people that I can count on to be there for me. To have found real friends and be able to work everyday at being a mother, wife, friend and human. I have the tools of the program, meetings and an amazing Sponsor. I know there is more to learn and problems I still struggle with, but today I'm good with that, knowing there is a solution and I'm not it.


