Says he, let's get back to coffee and cakes by cozy firesides. If any alcoholics stray our way, let's look after the. But that's enough. Simplicity is our answer. Quite opposed to such halcyon simplicity is the AA promoter. Left to himself, he would "bang the cannon and twang the lyre" at every crossroad of the world. Millions for drunks, great AA hospitals, batteries of paid organizer, and publicity experts wielding all the latest paraphernalia of sound and script; such would be our promoters dream. "Yes, sir," he

Quite opposed to such halcyon simplicity is the AA promoter. Left to himself, he would "bang the cannon and twang the lyre" For one, I'm glad we have both conservatives and enthusiasts. They teach us much. The conservative will surely see to it that the AA movement never gets overly organized. But the promoter will continue to remind us of our terrific obligation to the newcomer and to those hundreds of thousands of alcoholics still waiting all over the world to hear of AA. We shall, naturally, take the firm and safe middle course. AA has always violently resisted the idea of any general organization. Yet, paradoxically, we have ever stoutly insisted upon organizing certain special services; mostly those absolutely necessary to effective and plentiful Twelfth Step work. If, for instance, an AA group elects a secretary or rotating committee, if an area forms an intergroup committee, if we set up a foundation, a general office or a Grapevine, then we are organized for service. The AA book and pamphlets, our meeting places and clubs, our dinners and regional assemblies these are services, too. Nor can we secure good hospital connections, properly sponsor new prospects, and obtain good public relations just by chance. People have to be appointed to look after these things, sometimes paid people. Special services are performed. But by none of these special services has our spiritual or social activity, the great current of AA, ever been really organized or professionalized. Yet our recovery program has been enormously aided. While important, these service activities are very small by contrast with our main effort.

As such facts and distinctions become clear, we shall easily lay aside our fears of blighting organization or hazardous wealth. As a movement, we shall remain comfortably poor, for our service expenses are trifling.

2 2 With such assurances, we shall without doubt continue to improve and extend our vital lifelines of special service; to better carry our AA message to others; to make for ourselves a finer, greater Society, and, God willing, to assure Alcoholics Anonymous a long life and perfect unity.

- 7. Have I learned to step out of an AA job gracefully—and profit thereby—when the time comes?
- 8. What has rotation to do with anonymity? With humility?

### **Steering Committee Meeting Minutes**

#### Vancouver Area Intergroup of Alcoholics Anonymous Steering Committee meeting of September 13, 2021

Attendance: Dusty, Patrick, Alex, Julie, Phil, Michael, Laurie, Leanne, Bruce, Dee

Opening: The meeting was opened with the Serenity Prayer at 6:04pm

<u>Old Business/Outside Audit</u>: Laurie discussed the results of the outside audit and advised that the books are "cleaned up" from December 31, 2019 going forward. Issues prior to that date as clerical issues. There are no issues of misappropriation or malfeasance. Opportunities for improved processes were identified.

<u>Treasury</u>: Laurie advised that corrections need to be made to the cost of goods which will be done prior to the IG reps meeting. It was noted that group contributions are down while individual contributions are up. More fund raisers are needed to be conducted by groups noting the success of the reason event held by the Camas groups. Report accepted.

<u>Opening con't</u>: Minutes from the August SC meeting were accepted. Minutes from the August SC meeting were reviewed.

New Business/Office Manager Review: A motion was made that the office manager's review be moved from January to December in order to insure that SC members who actually worked with the office manager are involved. The motion was amended to make this an on-going procedure for the same reason. Motion passed. Office: Leeann reported that there are no issues at the office that are needing attention. There was a discussion regarding establishing a budget however it was noted that product ordering should be a direct relation to product sold. Leanne noted there have been issues where she has placed orders large enough to get free shipping but shipping costs were accessed due to out of stock situations. It was recommended she increase the order size to avoid these issues.

<u>Hotline</u>: The need for volunteers is unchanged. Please see the website for volunteer opportunities. Phil advised that he was approached by two AA members stating that hotline volunteers are being dismissed before a replacement is found. Phil said he was approached by another AA member who said the hotline was routed to Maureen (former hotline chair), that this was brought to the hotline chair's attention and no action was taken. <u>Old Business/Iron Horse</u>: A letter was sent to Iron Horse seeking an opportunity to reconcile the relationship. There was no response.

<u>New Business/Area Meeting</u>: The meeting to be held on the first weekend in October will be Zoomed from the office. Dusty said he can represent IG if a specific time is given when he can make a presentation.

<u>Old Business/Office Hours</u>: The SC was tasked to evaluate the effectiveness of the cutback in hours and make a recommendation to the IG reps for what action, if any, they would like to take. The SC will recommend to take no action and to give the cutback another month to see what trends might develop.

<u>Closing</u>: The meeting was closed with the Lord's Prayer at 7:18pm.


