There Is A Solution - page 25 AA Big Book

There is a solution. Almost none of us liked the self-searching, the leveling of our pride, the confession of shortcomings which the process requires for its successful consummation. But we saw that it really worked in others, and we had come to believe in the hopelessness and futility of life as we had been living it. When, therefore, we were approached by those in whom the problem had been solved, there was nothing left for us but to pick up the simple kit of spiritual tools laid at our feet. We have found much of heaven and we have been <u>rocketed</u> into a fourth dimension of existence of which we had not even dreamed.

The great fact is just this, and nothing less: That we have had deep and effective spiritual experiences which have revolutionized our whole attitude toward life, toward our fellows and toward God's universe. The central fact of our lives today is the absolute certainty that our Creator has entered into our hearts and lives in a way which is indeed miraculous. He has commenced to accomplish those things for us which we could never do by ourselves.

If you are as seriously alcoholic as we were, we believe there is no middle-of-the-road solution. We were in a position where life was becoming impossible, and if we had passed into the region from which there is no return through human aid, we had but two alternatives: One was to go on to the bitter end, blotting out the consciousness of our intolerable situation as best we could; and the other, to accept spiritual help. This we did because we honestly wanted to , and were willing to make the effort.

Chapter 2 - There is a Solution - (pp. 17-29) (aa.org)

Fourth Dimension of Existence p.25

Nobody got rocketed anywhere in the physical world until the 1960s. So, the writer in the 1930s who wrote we have been rocketed into a fourth dimension of existence wasn't referring to transportation, he was referring to transformation. It is easy for us who have seen men walk on the moon to miss that. We are not alone in missing the spiritual dimension. Jesus of Nazareth spoke of The Kingdom of God which is within. That dimension is also written in the Torah, the Dhammapada, and the Tao Te Ching.

Others have been missing it for a lot longer than we have been missing it in the Big Book. The people who have not missed it are called masters and mystics. We are living in that dimension whether we are aware of it or not. The fourth dimension is real, it exist, everywhere, all the time. Egos cannot enter the fourth dimension because egos are that part of our mind that think we are separate and in the fourth dimension we are in unity.

On page 25 and many other pages of the Big Book, the writer (a salesman first and foremost) is touting the benefits of recovery to give the reader a reason to continue reading. Recovery is getting your ego aside and shrinking your ego so that the real you can enter the fourth dimension and know it. The Big Book is written to low bottom drunks not to metaphysical scholars. That is why the higher meanings are easy to miss but they are certainly there.

Our message is This is what we did to recover. If you want to recover, do what we did. What we did and what you do, in the physical world, causes things to happen in the spiritual realm (the fourth dimension). At some point you will become awake to what happens in the spiritual realm Spiritual Awakening.

So to the newcomer who cant understand anything that is happening at meetings, know that there is a lot happening in the fourth dimension that you are very much a part of but cant yet see. For the religious person accustomed to being told what he/she should/should not do and being judged by doing/not doing, know that there is no judgment in the fourth dimension and that we are human beings not human doings. It isn't religion that we don't want in AA it is the judgment that we don't want in AA because we don't need it where recovery really happens.

Ebby Thacher:

Messenger, 12 stepper, sponsor, relapser

Edwin Throckmorton Thacher (1896-1966), more commonly known as "Ebby" is credited as Bill Wilson's sponsor (1998). Certainly that is the way that Bill Wilson himself referred to Ebby on numerous occasions (1957).

Ebby was the scion of a wealthy and powerful Albany, NY family and one of the Manchester, VT "summer people," who along with Lois Burnham (Wilson) was so admired by the youthful Bill Wilson.

Within Alcoholics Anonymous (A.A.) circles Ebby, sober at that time as a result of Oxford Group involvement, calling on Bill in 1934, is the prototypical "Twelfth Stepper." This is, of course, before there were the Twelve Steps. Bill was still drinking but his friend's obvious sobriety and happiness, despite the fact he had achieved it through "religious experience," anathema to Bill at the time, was a powerful attraction to Bill who was deeply unhappy.

Subsequently, Bill spent time with Ebby discussing the Oxford Group and its teaching, meeting other Oxford Group members and going to Calvary Episcopal Church with Lois, meeting Rev. Sam Shoemaker, and attending the separate Calvary Mission meetings which ministered to the homeless and where Bill, drunk, "stepped forward" and "testified." This really was his first spiritual experience and Bill noted that it had an effect on him, at least in the short run.

When soon thereafter in December of 1934 Bill was hospitalized again in Towns Hospital and had his dramatic spiritual experience it appears to have been Ebby who gave him a copy of William James' Varieties of Religious Experience, one source for the development of A.A. (2010).

Ebby, then exits center stage and is a minimal presence in most A.A. discussions as first William Duncan Silkworth, then Robert Smith, M.D., and the other cast of early A.A. founders and members step forward. For most interested in A.A., that's an end to Ebby. He was the messenger from the Oxford Group, the man who showed Bill sobriety was a possibility, the man who introduced him to Sam Shoemaker and William James.

But in reality Ebby, who Bill did regard as his sponsor, was a looming presence until his death in 1966, an exemplar of something that many appear to wish to forget: that alcoholism is a chronic illness characterized by relapse and that many people have periods of sobriety and active illness despite being exposed to the A.A. message. Further, that although the explanation for relapse within A.A. is that the relapsing person "Did not follow instructions." or "Did not work the Steps properly," the facts are that relapse is an exacerbation in a chronic illness and needs individual clinical assessment and an individual treatment response.

Multiple relapses were the course of Ebby's alcoholism and it's easy to see why the "rest of his story" has aspects of scandal and anxiety within A.A. circles. First within A.A. there are individuals who believe that they "know the answer" about staying sober, this "answer" is often associated with a strongly orthodox religious viewpoint despite A.A.'s best institutional efforts to rebut this approach. These dogmatists strongly suggest that if only people did A.A. this or that way, they would never drink again. Thus relapse is a result of not "doing" A.A. the way that these individuals demand. Ebby is then a prime example of this.

Alternatively, relapse is a frightening thing for recovering alcoholics. If a person who appears to be following an A.A. way of life can drink again then no one is really "safe" and I too, despite my best efforts might get sick again and suffer the terror and degradation of active alcoholism. This line of thinking characterizes all individuals who have chronic illness and become aware of other individuals who become ill again.

Third, many individuals in early A.A. who knew both Bill and Ebby took a dim view of Bill's repetitive attempts to help Ebby. As Ebby's biographer (1998) describes, Bill contributed to Ebby's financial support and encouraged other's to do so even when Ebby was drinking. This is regarded as "enabling." Bill reached out to friends and colleagues in A.A. to try and help Ebby in other ways, with employment, or placement in various rehabilitation programs. These interventions too, would be viewed as counter-therapeutic by many. Bill invited Ebby to speak at several A.A. conventions during periods when Ebby was sober but many saw this as scandalous because of the pattern of remission and relapse Ebby demonstrated. Further like many alcoholics Ebby was a great guy when he was sober but an irritating and emotionally troublesome person when he was drinking. Thus like a member of the family who is an active alcoholic he was the object of intense negative emotions.

While Ebby Thacher is important for helping Bill become sober, his complete story is also important because it elaborates the complete story of alcoholism. Many people who follow an A.A. program are able to establish permanent sobriety. Some others are not so fortunate. Ebby's life story shows that continued efforts to openly discuss and understand relapse are desirable and should be encouraged. They also remind us that sobriety is a daily affair not always measured in permanent abstinence.

Ebby died in 1966. He was living, with Bill Wilson's support, at a small A.A. rehabilitation program, McPhee Farm, in Vermont.

He was apparently sober when he died.

Vancouver Intergroup Treasurer's Report- February 2022

Dear Vancouver Intergroup,

Moving forward we will be sharing financial data out of QuickBooks and bank balances directly to avoid transcription or other manual processing errors. After some initial review and discussion with our office manager, I'd like to note a few items.

- There is no active CPA review, compilation or reconciliation of financial data
- The system is cash based accounting and have non standard inventory tracking, which accounts for occasionally variability in COGS on the income statement
- Many processes are very manual e.g. payroll, processing orders, etc.
- We have a CPA that I am trying to assess what they do. Looks like sales tax filings, but oddly also payroll for one staff member with manual checks. I need to confirm who prepares the annual tax return.
- Our only online payment method is through PayPal. We could add free transfer accounts like Venmo or CashApp for groups and individuals to submit contributions.
- There are some older entries that need to be corrected
- Tracking group contributions is very manual and dependent on each contribution being clearly marked with a group so that it can be tallied, whether made via cash, check or online. If this isn't marked clearly, the donation will not be credited to the group.
- Our instance of QuickBooks is not currently directly linked to online banking.
- We are in the process of upgrading the office computer and porting over all software and data to the new one .
- We don't currently have accurate prepayment amortization or a process to book these properly so they are showing as large one-time expenses due to the cash basis accounting.
- Short-term, the priority will be to monitor cash changes month to month, any significant variations in expenses, and generally ensure sustainability and continuity of the office by ensuring we are proactively identifying any cash flow issues.

Overall, I see a number of areas we could streamline and automate to reduce errors and cost. I will be evaluating these with LeAnne and hope to have some help with implementation. This will be a gradual process over the two year term as we assess, prioritize and make systematic changes. Some ideas and projects are below:

- I've asked LeAnne to start documenting in a simple format all of the processes in the office so that we can assess them for improvement and/or automation.
- For accounting controls, cost reduction and eliminating errors: moving to an automated payroll service like Gust, QuickBooks, ADP, etc. These are typically low cost and handle all filings, do direct deposit and are scalable if needed.
- Investigate re-allocating accounting spent on payroll and other areas to monthly or quarterly closes and reviews.
- I'd like to link our accounts to QuickBooks and start using the balance sheet report.
- A non accounting project that would save the office a lot of labor, errors and increase usability of the alcoholics serve would be to add a basic email marketing tool like MailChimp and a signup form to the website and in all of our emails. This can then be used for sending out the newsletter and easy self service subscribe/unsubscribe functionality for our members. This is currently a manual process and has a lot of error.

This past month, we saw an increase in a few one time expenses with the purchase of our computer and professional charges from Butterfield accountants. I plan to look into the services provided by Butterfield. Overall, we are in healthy financial condition with a full prudent reserve and a fairly typical balance in the primary checking account. We will monitor the cash flow to ensure that we maintain our position. Some highlights/comments on the report are below:

- Total income was \$4,362.69 o Merchandise sales were \$1,690.64. Only a slight decrease from the previous period. o Group contributions were \$2,11.74. Roughly the same as the previous period. o Individual contributions were \$560.31. Significantly higher than the previous period.
 - COGS were down significantly from the previous period, again, this is due to how we track our inventory so not a very important number to track unless we change our accounting process.
 - Our total expenses were \$6,590.03. Spending increased slightly from the prior period. The computer purchase and accounting charges will be investigated.
 - Total cash on hand is \$29,444.06. O Prudent reserve has \$13,003.58. This amount is basically unchanged other than small interest accruals. O The main checking account ended the month with \$15,040.48. This account saw a decrease of \$2,246.69 from the previous month. This account was \$9,511.70 higher than it was in January 2021. O The event account has \$1,400. This was unchanged.
 - We will need to continue monitoring retail sales, expenses and group contributions to assess the sustainability of current expense levels, but there is nothing in this past month's statement that raises any alarms.

The person was contacted, acknowledged the purchase, but to date has failed to reimburse IG. A motion was made to file a dispute of the charge. It was noted that the dispute may require a police report be made. The motion was amended to authorize the reporting. A request was made to allow Alex one more opportunity to request reimbursement. The motion was again amended to take no action until after 2/16/22. Motion passed.

Closing: The meeting was closed with the Lord's Prayer at 6:25pm


Message from Ukraine AA Service Office and Ukraine AA Service Council dated February 28, 2022.


